### CONDITIONS OF ENTRY:

1. A cataloguing fee of \$748 (inc GST) must accompany entry and will be refunded if the horse is not accepted. All sales incur 10% GST, unless you are not GST registered.
2. All the horses accepted for the auction must be at the auction venue by the Saturday morning, the day of the auction weekend. Signage will be provided for each stable door to help buyers identify auction lots.
3. All horses remain at risk of the vendor in respect of any damage or injury until the horse has been sold. Auction of the Stars nor the owner/manager of the auction venue shall accept any responsibility for any claims, losses, suits, and damages made against or suffered by them by reason of any negligent act or omission on the part of any rider, trainer or attendant whilst he is attending or otherwise handling a horse.
4. Upon sale of the horse the auctioneer will take 10% commission + GST.
5. Final selection of the auction horses will be driven by commercial considerations.
6. The entries of the highest standard will initially receive priority.
7. The reserve price will be evaluated and any entry with an unrealistically high reserve is unlikely to be accepted. **Please note: if an entry is accepted and the reserve is exceeded at auction, but the vendor changes their mind and decides to increase the reserve (or not sell), the vendor will be charged 10% commission plus gst on the passed in price by Auction of the Stars whether the horse is sold or not.**
8. The auction is run under a full set of auction conditions (able to be read on our website at [www.auctionofthestars.com](http://www.auctionofthestars.com)).
9. All entries **must be accompanied at the time of auction by a certificate of good health** from a veterinarian.
10. The auction catalogue will be available on the website approximately 6 weeks before the auction date and will be widely distributed to thousands of email address nationally and internationally..
11. The seller of any horse that does not present to the auction will be charged 10% of the above nominated reserve price plus GST unless a vet certificate is produced to excuse its absence.
12. **Once accepted, no horse may be sold prior to auction.** The auction is not to be a collection of equestrian leftovers but an elite presentation of horses!
13. The seller of any horse sold within a 45-day period post-auction to any buyer or during the next three months to a bidder from the auction or to a buyer introduced to the seller by AOS, will be liable to pay 10% of its sale price to Auction of the Stars.
14. Auction of the Stars undertakes to further advertise any horses that may be passed in at the auction on its website at [www.auctionofthestars.com](http://www.auctionofthestars.com) for a period of three months post-auction.

15. Any previous operations, ongoing medical conditions or genetic faults (eg parrot mouth) must be declared on this application form although these do not necessarily preclude the horse from being accepted.
16. **Each vendor is required to take out at least a quarter-page colour ad** in Horse Deals in the chosen issue as surveys show that potential buyers do align their interest with a chosen horse before the auction. These ads will be run under the Auction of the Stars banner for maximum effect. They are organised by Auction of the Stars. You will be contacted by Horse Deals for individual payment.
17. Horses must arrive at the auction accompanied by their registration papers.
18. The seller agrees to present their horse on the day of the auction in Auction of the Stars uniform as provided by Auction of the Stars. Please note that AOS has a number of sponsors which all sellers will support by wearing supplied uniforms (jacket or vest, cap, shirt and saddlecloth). These items are then the property of the seller. In extenuating circumstances where seller sponsors are in conflict with Auction of the Stars sponsors, a seller may be given special consideration for exemption from AOS uniform. That decision will be made by AOS directors. There will be no private sponsorship advertising.
19. Application does not guarantee acceptance. Entries are made under the following conditions and understandings.
20. There will be a final selection of horses reducing numbers to a maximum of about 25.

No horse will be considered unless:

- **All fees** are paid by the nomination closing date.
- This **signed** form is included, either by email, fax or mail.
- A clear, side-on, **high-resolution photograph** of the horse is sent via **email. Please do not edit the photo. Entries WILL NOT be accepted if the photograph is not at least 900kb.**
- Copies of all registration papers and performance cards such as issued by the EFA, a studbook certificate etc are included.
- The reserve price is nominated with the entry form.
- The certificate of good health must be provided on arrival.
